and R. Islwyn Pugh.....

of 3, Lloyds Terrace, Penydarren, Merthyr Tydfil.....

(hereinafter called "the Representative") of the fourth part

WITNESSETH

1. The Apprentice/~~Trainee~~ (with the consent of the Guardian until the Apprentice/~~Trainee~~ shall reach the age of 18 years) hereby covenants with the Employer and also as a separate covenant with the Representative to serve the Employer faithfully and honestly in all respects as from the^{4th.}..... day of^{October}..... 1971...for the period of^{2...11/12 yrs...}..... (hereinafter referred to as "the period of service") as an Apprentice/Trainee in the occupation of^{Mason.}.....(hereinafter referred to as "the occupation") and to observe and be subject to the conditions contained in the Schedule annexed hereto

2. The Employer hereby covenants with the Apprentice/~~Trainee~~ (and until the Apprentice/~~Trainee~~ shall reach the age of 18 years with the Guardian) and also as a separate covenant with the Representative to receive the Apprentice/~~Trainee~~ into his service for the period of service and to the best of his knowledge power and ability to teach and instruct him or cause him to be taught and instructed in the occupation and in all things incidental or relating thereto and to observe and be subject to the conditions contained in the Schedule annexed hereto

3. The Representative has been selected by the^{Aberdare & Merthyr} Joint Training Committee constituted by the National Joint Council for the Building Industry (hereinafter referred to as "the Council") to be a party to this Agreement.
